For any charges of fines not listed above, contact the appropriate court clerk as indicated. If found guilty of

NO INSURANCE violation, your driver’s license may be suspended until you can prove to the State that you have acquired Liability Insurance. Where proof is shown that you were insured, the charge will be dismissed.

On charges involving EXPIRED driver’s license, motor vehicle inspection stickers, and registration, the Court may dismiss these charges if corrected within 10days of offense, provided you furnish the court with dated receipt confirming the same.
