Gentlemen:

The estimated values presented to me this past spring predicted that we would have a reduction of appraised values of approximately 20%. When the certified values were given to Panola County on July 22, 2011, the reduction was approximately 11%. In preparing the budget, we knew that to maintain the revenue from FY2011, a tax rate increase would be necessary. Panola County is now debt free and that is a plus for setting the tax rate as well as some general line item reductions that help keep the tax rate down. A reduction in the tax levy is also instrumental in keeping the tax rate lower. With this proposed budget, we are still able to keep the tax rate under the effective rate.

This budget reflects the continuing escalation of insurance costs particularly health insurance premiums increasing 5.9%. Also in this budget is a cost of living salary increase for all employees of 3%. This budget includes the addition of two new part-time deputy constables. The deputy constable position will have to be approved at a later time according to Loc. Govt. Code 86.

My goal for the 2012 budget and I believe the goal of the entire Commissioners' Court for 2012 was to be as fiscally conservative as possible and still meet the needs of Panola County. In these economic times, I believe this budget will achieve that goal and I urge its adoption without change.
