An election is hereby ordered to be held on November 5, 2019 for the purpose of:

For the purpose of adopting or rejecting the proposed Constitutional Amendments as submitted by the Legislature, 86<sup>th</sup> session(s), of the State of Texas; and for the purpose of adopting or rejecting the proposed Panola County Emergency Service District Number 1 to impose a sales and use tax in the amount of \$0.005 per dollar (one-half cent per one dollar) in the area of Panola County outside the city limits of Carthage, Texas.
