Gentlemen:

The estimated values presented to me this past spring predicted that we would have a reduction of appraised values of almost 18%. Fortunately when the certified values were given to Panola County on July 23, 2010, the reduction was approximately 4%. This allowed our budget to contain items that enable us to better serve the citizens of Panola County and still remain within the parameters we decided in the budget workshop.

This budget reflects the continuing escalation of insurance costs particularly health insurance. Also in this budget is a cost of living salary increase for all employees of 3%.

My goal for the 2011 budget and I believe the goal of the entire Commissioners' Court for 2011 was to be as fiscally conservative as possible and still meet the needs of Panola County. I believe this budget will achieve that goal and I urge its adoption without change.

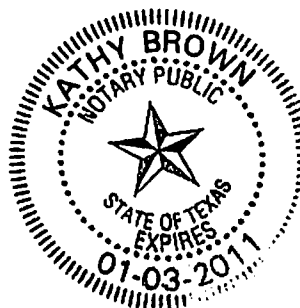
