**SCHOOL DISTRICTS: The school M&O tax rate limit is \$1.17 for districts with 2005 M&O rates of \$1.50 or lower. For districts with 2005 M&O rates above \$1.50, the limit is the sum of \$0.17 and the state compression rate multiplied by the 2005 M&O rate. The I&S tax rate limit is \$0.50 for 'New' debt plus a rate for 'Old' debt. 'Old' debt is debt authorized to be issued at an election held on or before April 1, 1991, and issued before September 1, 1992. All other debt is 'New' debt. See State Comptroller's truth-in-taxation guide for more information.
