

Panola County Clerk Fee Schedule

Effective January 1, 2024

Notice: E-File Mandate effective January 1, 2016 for Panola County. Per the Texas Supreme Court Mandate Miscellaneous Order MD 12-9208, all documents that are part of civil matter, including probate cases, must be e-filed. This mandate does not apply to individuals who are *not represented* by attorneys. Exceptions to e-filing requirement include wills submitted in probate cases. If a will is filed electronically, the original must be presented to the Clerk's Office within three (3) business days after the application is filed. In addition, the following documents must not be filed electronically: documents filed under seal or presented to the court in camera, and documents to which access is otherwise restricted by law or court order.
