

## Panola County Clerk Fee Schedule

Effective January 1, 2024

TX Property Code § 11.003, effective Jan. 1, 1982 requires that each grantee's mailing address be in or attached to any document conveying real property executed after Dec. 31, 1981. If address of each grantee is not included, the payment of a penalty filing fee equal to twice the statutory filing fee of such documents with the County Clerk will be required. This fee is in addition to regular filing fees. LGC §191.007(c)(h) provides double the filing fee for the first page if there is not a clearly identifiable heading; LGC § 191.007(e)(h) provides double the filing fee for that page if names are not legibly typed or printed immediately under each signature; and LGC § 191.007(b)(3) requires that the type not be smaller than 8 pt. on a document presented for recording.
