

HOLLAND, ET UX, AND RECORDED IN VOLUME 663, PAGE 496, OF THE DEED RECORDS, PANOLA COUNTY, TEXAS, SAME BEING PART OF COLLEGE CIRCLE ADDITION, AND BEING MORE FULLY DESCRIBED AS FOLLOWS:

Beginning at a pk nail set in pavement at the intersection of College Circle Street and West Holland Street;

Thence S 13°00'00" E (bearing basis) with the east line of College Circle Street a distance of 130.00 feet to a 3/8-inch iron rod found for the southwest corner hereof;

Thence N 73°02'38" E a distance of 123.00 feet to a 1/2-inch iron rod set for the southeast corner hereof;
